Police Officer Christopher Quirk, shield 08692 of the 014 Precinct-Midtown South Precinct, states as follows:

On March 30, 2007, at about 21:00 hours at West 43rd Street & 7th Avenue in the County and State of New York, the Defendant committed the offenses of:

- 1. PL195.05 Obstruction of Governmental Administration in the Second Degree (1 count)
- 2. PL240.20(6) Disorderly Conduct (1 count)

the defendant intentionally prevented and attempted to prevent a public servant from performing an official function by intimidation, physical force and interference and by means of an independently unlawful act; and the defendant, with intent to cause public inconvenience, annoyance and alarm and recklessly creating a risk thereof, congregated in a public place with other persons and refused to comply with a lawful order of the police to disperse.

The offenses were committed under the following circumstances:

Deponent states that deponent observed the defendant standing over Sergeant Timothy Horohoe, shield #904170 of the 14th Precinct, taking pictures of Sergeant Timothy Horohoe affecting the lawful arrest of two separately charged individuals. Deponent further states that Sergeant Timothy Horohoe told the defendant that the defendant was allowed to take pictures as long as the defendant backed away from Sergeant Timothy Horohoe while Sergeant Timothy Horohoe was affecting said lawful arrest. Deponent further states that the defendant refused to back away from said lawful arrest and deponent observed the defendant kneel directly behind Sergeant

Timothy Horohoe while approximately four other separately charged individuals surrounded Sergeant Timothy Horohoe. Deponent further states that the defendant's conduct interfered with Sergeant Timothy Horohoe's free movement and obstructed Sergeant Timothy Horohoe's ability to affect the lawful arrests of said separately charged defendants. Deponent states that the defendant's above-described conduct created a public disturbance/inconvenience in that it caused a crowd to gather, disruption of the normal flow of traffic and caused people to express alarm. **False statements made herein are punishable as a class A misdemeanor pursuant to section 210.45 of the penal law.**

The defendant intentionally prevented and attempted to prevent a public servant from performing an official function by intimidation, physical force and interference and by means of an independently unlawful act, and the defendant, with intent to cause public inconvenience, annoyance and alarm and recklessly creating a risk thereof, congregated in a public place with other persons and refused to comply with a lawful order of the police to disperse.

The offenses were committed under the following circumstances:

Deponent states that while the deponent was affecting a lawful arrest of separately charged defendant Joyce Lin (M07629335R), deponent observed the defendant on a bicycle that had a fifteen foot pole attached to said bicycle with a camera attached to said pole standing over the deponent, interfering with the above-described lawful arrest. Deponent further states that the defendant's above-described actions obstructed the officer's free movement and ability to affect the arrest of separately charged defendant Joyce Lin (M07629335R). Deponent further states that the defendant was a participant in a protest, with approximately forty other individuals, and

refused to leave the area after being asked twice by Sergeant Timothy Horohoe, shield #01657 of the 14th Precinct-Midtown South, to leave said area. Deponent further states that the defendant's conduct created a public disturbance/inconvenience in that it caused a crowd to gather, disruption of the normal flow of traffic and caused people to express alarm.

The offenses were committed under the following circumstances:

Deponent states that deponent told defendant multiple times to move from where she was

standing because she was interfering with police activity and defendant refused to comply numerous times. Deponent further states that when she was placing the defendant under arrest for the offense(s) described above defendant kicking her legs and flailing her arms and trying to run away from the officers.

Deponent further states that deponent is informed by Police Officer Richard Pierre, Shield No. 4236, of the Midtown South Precinct, that while informant was assisting in placing the defendant under arrest for the above-described offense(s), defendant bit the informant on the left hand, causing him to suffer substantial pain and injury, to wit an open wound/bite mark to his left hand.

Deponent further states that deponent is informed by Police Officer Kevin Stewart, Shield No. 14870, of the Midtown South Precinct, that while informant was assisting in placing the defendant under arrest for the above-described offense(s), defendant bit the informant on the right hand, causing him to suffer substantial pain and injury, to wit an abrasion/bite mark to his right hand. Deponent further states that deponent is informed by Sergeant Timothy Horroch, Shield No. 1657, of the Midtown South Precinct, that informant Horroch recovered a switchblade knife from the ground where defendant was lying and from his training and experience knew said knife to be a switchblade because it locked into place when informant pressed a button.
